We voted on this plan and I feel this membership has a right to vote on any such drastic change, such as that taken place Jan. 1, and not be told "this is the way it has to be". Baloney!

I have been studying two plans, Local #638 of the Steamfitters can borrow \$2,500 a year if they want it for any reason. They pay taxes on doing so instead of delaying it like we do. Local #3 of the Electricians can borrow \$1,000 per year for any reason. Now, when you tell me that we have to have what we have, without consulting the general membership, I say baloney again.

Before the next contract comes around, I will get petitions out so the majority voice can be heard.
