Hi Brothers.

The biggest problem we have in Local 1 continues to be unemployment. Since we returned to work after the strike (or more aptly, lockout) in early 1973, about 350 of our Brothers have been laid-off in construction. Some are working in maintenance and repair. Some are running cars. But approximately 100 more recently laid-off Brothers have no work. Our Business Agents have been trying to locate jobs in other industries, but work is scarce all over. Realizing you probably have similar problems, any help from other locals in the IUEC would be greatly appreciated.

There are some things we all can do. Brothers working in construction: secure your work. Do not cut corners or become speed demons on the job. Work sage. If a temporary car can be manned, call it in to the rooms. If there are any doubts, let your B.A. make the decision.

In maintenance, don't be brow beaten into doing work that should be repair. If you are ordered to do a possible repair job, make sure you complain to your shop steward or B.A. Make sure any repair work needed on your jobs has been requested on repair work requisition forms. The more the economy declines, the less work some companies want to give to repair. Don't take it personal. They aren't questioning your ability. It just simply IS NOT YOUR JOB.

There is something we all can do no matter what department we are in, or over of we are out of work. Keep our eyes and ears open for possible jobs outside the business. If you hear of a job, call the Union or call a brother who is out of work. Check renovation jobs in your area for new elevator work and the possibility of a non-union elevator shop

on the job. Don't just walk by!

Unemployment benefits in New York (\$95.00) have been extended another 13 weeks, to 52 weeks, as of January 8. Don't forget, we are eligible for food stamps while unemployed. Also, you may borrow up to \$75.00 per week from the annuity after 21 days out of work.

Rumor has it that some companies have already decided to sign interim contracts in the event of a strike or lockout.

The International has rendered a decision on the scabs who worked during the strike and appealed the Local #1 decision to the International. The fine has been set at approximately \$2,000 each as per the International Constitution and By-Laws.

A retirement dinner was held for George Kemly on Wednesday, January 9th, at the Promenade Restaurant at Rockefeller Center. George has been in the business for 47 years. He started with Gurney Elevator Company as an apprentice, working with his father George Sr., who has since passed away.
