In last month's article, I wrote a paragraph on the Common Site Picketing Bill, which was rejected by the House of Representatives. This bill (HR4250) would have permitted job site picketing by the trades if anyone of the trades had a grievance with one contractor and to establish a construction industry collective bargaining committee. As promised, I have compiled a list of the congressmen in Local No. 1 jurisdiction who voted down the bill. The following is a list of New York State congressmen who voted AGAINST this bill and the Construction trades:

CD No. 4, Lent; CD No. 5, Wydler; CD No. 25, Fish, CD; No. 29, Pattison; CD No. 30, McEwen; CD No. 31, Mitchell; CD No. 35, Conable; CD No. 38, Kemp.

The following is a list of New Jersey State Congressmen who voted AGAINST this bill:

CD No. 2, Hughes; CD No. 5, Fenwick; CD No. 6, Forsythe; CD No. 9, Hollenbeck.

Incidentally, for general information, the bill was rejected 205-217: Republicans 14-129, and Democrats 191-88. I found all of the above information in the Congressional Quarterly. If you would like to know how your congressman or senator votes (or doesn't vote), just go to your public library and skim through this book—it's quite interesting.

New York, always known for the biggest and the best of everything, is doing it again. Naturally, it is only on the drawing board now but in the near future, New York City will start building a twenty square mile island off its coast.
